**ANTIFLOR**

Anti-flor tablets

	<p><b>COMPOSITION</b> Allyl iso-thiocyanate on paraffin support.</p>
	<p><b>GENERAL CHARACTERISTICS</b> Product containing allyl isothiocyanate (mustard essence), supported by food-grade paraffin. Mustard essence slowly evaporates from the floating paraffin support and saturating the air over the wine, prevents the growth of "film" forming yeast on the surface of not fully topped tanks and barrels.</p> <p>Antiflor is available in three sizes:</p> <ul style="list-style-type: none"> <li>Antiflor Damigiane (demijohns), 1-gram tablet containing 0.5% iso-thiocyanate, suitable for containers from 20 to 200 L (5 – 53 gal);</li> <li>Antiflor Fusti (barrels) 7-gram tablet containing 1.7% iso-thiocyanate, suitable for containers from 200 to 5000 L (53 – 1320 gal)</li> <li>Antiflor Vasche (tanks), 20-gram tablet containing 2% iso-thiocyanate for tanks over 5000 L (1320 gal)</li> </ul>
	<p><b>APPLICATIONS</b> Prevention of surface "film" yeast spoilage.</p>
	<p><b>DOSAGE</b></p> <ul style="list-style-type: none"> <li>Antiflor Damigiane: 1 tablet per demijohn</li> <li>Antiflor Fusti: 1 or 2 tablets per container from 200 L to 5000 L</li> <li>Antiflor Vasche: 1 or 2 tablets per tank over 5000 L</li> </ul> <p>In EU, use of Antiflor in container smaller than 20 L (5 gal) is forbidden.</p>
	<p><b>INSTRUCTIONS FOR USE</b> Place Antiflor tablet on wine surface and accurately close the container. Replace the tablet every 3-4 weeks.</p>
	<p><b>PACKAGING AND STORAGE CONDITIONS</b> Antiflor Damigiane: display box containing 40 sachets with 12 tablets each; Antiflor Fusti: display box containing 40 sachets with 2 tablets each; Antiflor Vasche: display box containing 45 sachets with 1 tablet each.</p> <p>Sealed package: store in a cool, dry and well-ventilated area. Opened package: carefully reseal and store as indicated above.</p>
