

# FINING AGENTS

Fining agent to prevent and treat reductive notes



#### COMPOSITION

Bentonite, pea protein, copper citrate (approx. 2%).

## **GENERAL CHARACTERISTICS**

REVELAROM is a complex fining agent that effectively removes sulfur compound odors.

It is used to treat wine before bottling to prevent the appearance of reductive aromas in bottle and those linked to light exposure (light-struck).

In wines that already have "closed" or reductive odors, REVELAROM eliminates atypical odors arising from hydrogen sulfide and its derivatives, thus heightening fruit aromas.

Due to its formula, treatment with REVELAROM is effective for both the prevention and treatment of reduction odors without causing negative effects associated with copper sulfate use. REVELAROM not only improves aroma, but also taste because it eliminates the metallic taste associated with copper treatments, reduces the bitter taste that arises from products with reactions between sulfur and polyphenol compounds and prevents copper haze.

## APPLICATIONS

- Prevention of post-bottling reduction
- Prevention of the light-struck defect
- Aromatic treatment of wines with evident reduction problems
- Aromatic "opening" of wines that are "closed" due to the presence of sulfur compounds

#### DOSAGE

- 2 5 g/hL (0.16 0.4 lb/1000 gal) for prevention before bottling
- 5 10 g/hL (0.4 0.8 lb/1000 gal) for treatment
- Up to 50 g/hL in exceptional cases

1 g/hL of REVELAROM provides 0.07 mg/L of copper to wine.

Maximum legal dosage in the EU: 50 g/hL. The final copper content should not exceed 1 mg/L.

Preliminary laboratory trials are recommended to determine the correct dosage.

#### INSTRUCTIONS FOR USE

Dissolve REVELAROM in cold water at a 1:10 ratio, while mixing well to obtain good dissolution. Allow the solution to sit for one hour and then add to wine during a pump-over using dosing pump or Venturi tube. Wait 1-2 days for the product to settle well then filter.

When REVELAROM is used in combination with other fining agents, it is advised to add it before other products.



# PACKAGING AND STORAGE CONDITIONS

1 kg, 10 kg

Sealed package: store in a cool, dry and well-ventilated area. Opened package: carefully reseal and store as indicated above.
